BY THE HEARING OFFICER:

On September 7, 2021, Families and Connections Transporting Services, LLC ("Applicant"), Omaha, Nebraska, filed an application seeking authority as a contract carrier in Nebraska intrastate commerce in the transportation of passengers in open class service within Douglas and Sarpy counties, and between said counties, over irregular routes pursuant to a contract with the Nebraska Department of Health and Human Services, a Medicaid-managed care organization under contract with NDHHS, or another agent working on behalf of NDHHS. HHS Designation is yes. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on December 7, 2021.

Timely protests were filed by Camelot Transportation, Inc., and Triumph Transportation, Inc. Protests were granted on January 20, 2022.

On March 10, 2022, a planning conference was held to discuss a procedural schedule and set a hearing date. Dillon Keiffer-Johnson appeared on behalf of the Commission. The following appeared via telephone: Ms. Janelle Hardiman on behalf of Applicant

As a result of the planning conference, several procedural deadlines were decided. Therefore, this Order serves to memorialize those decisions and provide a timeline for proceeding in this docket. I find that the following schedule should be adopted:

Parties

Ms. Hardiman is representing Families and Connections Transporting Services, LLC in this proceeding, and is not licensed to practice law in any jurisdiction. Under Rule 002.04C of the Commission Rules of Procedure, an individual who is not licensed to practice law may appear for a governmental subdivision, corporation, association or partnership for the sole purpose of making a statement, but may not elicit testimony from another person. In accordance with the rule, Ms. Hardiman's participation in this proceeding will be limited to a statement at the hearing. Ms. Hardiman will also not be permitted to enter exhibits, call witnesses to testify, or cross-examine any of Protestants' witnesses. Should Applicant decide to retain an attorney for this matter, the Commission must be notified and the attorney must file an entry of appearance prior to the proceeding.

Service

All documents shall be served to all parties of record. Documents shall be typed, in writing, and filed via U.S. mail. A statement certifying that a copy of the filing was served on all parties in the docket must be included with any filing. Any documents served after 5:00 p.m. shall be considered filed the following day. Parties are responsible for maintaining an accurate service list.

Protestants shall file a witness and exhibit list with the Commission, including copies of all exhibits to be presented at the hearing no later than 5:00 p.m. on March 30, 2022. Copies of the exhibit and witness lists and exhibits shall be served on the opposing party via first class mail.

Discovery

The Nebraska Discovery Rules may be referenced for general guidance as to the conduct of discovery. Parties should make good faith efforts to resolve any discovery disputes.

Discovery requests are limited to Protestants, as they are represented by attorneys licensed to practice law in Nebraska. Applicant may not issue discovery requests and is limited to issuing discovery responses to Protestants' discovery requests.

Courtesy copies of any discovery requests and responses should be sent to the Commission either by U.S. mail or electronically to psc.motorfilings@nebraska.gov. Such discovery requests and responses shall not be part of the official record unless offered and accepted as exhibits during the hearing.

In the event that timely responses to written interrogatories or document requests are not forthcoming, Protestants should promptly file a motion to compel, which shall set forth the date the discovery was served, the due date for responses, with an averment of the default. Upon receipt of such motion, the Hearing Officer, without waiting for a response, may enter an order directing discovery be provided by a certain date. Failure to comply with such order may result in sanctions or other actions.

In the event of a discovery dispute arising by reason of Applicant's objections, the parties shall promptly and in good faith exert every effort to resolve their differences. In the event of objections to certain discovery, Applicant shall provide all other discovery that is not objectionable. In the event that any disputes cannot be resolved, the dispute shall be submitted to the Hearing Officer through Commission Legal Counsel by email to psc.motorfilings@nebraska.gov, attaching a copy of the pertinent discovery request and response or objection. The email may also include a short statement of the party's position. The Hearing Officer will schedule a telephone conference, and will issue an order resolving the dispute after said conference.

Protestants will have the opportunity to enter exhibits and present witnesses on their behalf. Applicant and all witnesses will be subject to questions from the Commission.
