#### BY THE COMMISSION:

On January 13, 2022, Medics At Home, Inc. ("Applicant"), Omaha, filed an application for authority to amend its rates and charges by reestablishing its base rate and mileage charge and incorporating other add-on charges. Emergency action is requested.

#### OPINION AND FINDINGS

Applicant is a Nebraska Corporation with its principal place of business in Omaha, Nebraska. Applicant is a certificated carrier that holds Certificate B-1817. The Certificate authorizes Applicant to provide transportation of passengers in non-emergency service for hire of the handicapped, physically limited and elderly, who do not need or expect to need medical assistance in route, in vehicles specially designed by the accommodation of wheelchairs, on demand response or advance reservation basis between points in Nebraska over irregular routes.

Applicant is seeking to amend its existing rates previously granted under Rate Docket LR-335.¹ Applicant is seeking to reconfigure its base rate to \$45.00 and its per mileage charge to \$3.00 per mile. Applicant further seeks to increase its oxygen charge to \$15.00. Applicant also proposes the addition of a cleaning charge of \$50.00 applied only to the provision of services to those passengers that are COVID-19 positive. Lastly, Applicant seeks to establish a wait time charge of \$20.00 per every 15 minutes. A review of Applicant's proposed rate in comparison to rates offered by similar carriers for similar services finds that the proposed rate is reasonable.

In applications such as these, the Commission must find that an emergency situation exists. The Commission finds that the

increase in fuel costs, employment costs, and operational costs are sufficient to find that an emergency basis exists for granting the reconfiguration of Applicant's base rate and per mileage charge. The proposed rates are in line with the increases experienced by the Applicant and the Commission finds that these increases should be approved on an emergency basis. However, in analyzing the proposed COVID-19 cleaning charge, the Commission is of the opinion and finds that rate cannot be approved without additional information from the Applicant to validate the rates and need for emergency action.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted in part and denied in part on an emergency basis effective March 15, 2022. The Commission further finds that the Application should be processed pursuant to Commission rules regarding rate applications. Medics At home, Inc.'s complete list of approved rates and charges are attached to this Order as Appendix A.

#### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the application filed by Medics At Home, Inc., Omaha, Nebraska be, and it is hereby, granted in part and denied in part to amend its rates for its services effective March 15, 2022, attached hereto as Appendix A.

IT IS FINALLY ORDERED that public notice of this action be published in  $\underline{\text{The Daily Record}}$ , Omaha, Nebraska, pursuant to the provision of Neb. Rev. Stat. § 75-121 and Commission Rules.
