## OPINIONS AND FINDINGS

On January 4, 2022, the Nebraska Public Service Commission ("Commission"), on its own motion, sought to address certain carriers in non-compliance with annual renewal requirements. My Princess' Limo Services, LLC ("Applicant"), was ordered to appear at a show-cause hearing scheduled for January 25, 2022. Prior to the hearing, Applicant contacted the Commission to start the process to voluntarily suspend its services. The Commission entered an Order on February 1, 2022 in Docket No. MT-0001.02, finding that Applicant's suspension request should be granted.

On February 11, 2022, My Princess' Limo Services, LLC, filed an application to suspend its operations until May 23, 2023. In its request, Applicant stated the vehicle used in its operation was in need of extensive repairs and ownership may need to relocate.

#### OPINION AND FINDINGS

My Princess' Limo Services, LLC, is a common carrier authorized to provide transportation of passengers by luxury or stretch limousine in limousine service between points in Madison County and communities within a 60-mile radius of Madison County over irregular routes. The transportation of railroad train crews and their baggage is not authorized and HHS designation is no.

Neb. Rev. Stat. § 75-315 provides that a certificate or permit may be suspended, changed, or revoked by application of the certificate or permit holder or on the Commission's own motion after a hearing is properly noticed and held. Testimony at the January 25 hearing and communications held with the Applicant illustrated My Princess' Limo Services was having difficulties in providing its services. Thus, hindering its ability to comply with annual renewal requirements under § 75-305. My Princess' Limo Services filed its suspension request on February 11, 2022. The Commission's February 1, 2022 Order in Docket MT-0001.02 determined that My Princess' Limo Services' request to suspend its authority should be granted and that a separate Order would be entered. Therefore, this Order shall serve to memorialize the finding the Commission's February 1, 2022 Order. The Certification of Public Convenience and Necessity held by My Princess' Limo Services, LLC, should be suspended until May 23, 2023. My Princess' Limo services will need to come into compliance with all Commission requirements either on or before the end of the suspension period or make other arrangements with the Department regarding its authority. Failure to do so may result in further Commission action.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request of My Princess' Limo Services, LLC, Madison, Nebraska, to suspend the Certificate of Public Convenience and Necessity issued in Docket No. B-2006 be, and it is hereby, granted, and Certificate B-2006 is suspended until May 23, 2023.
