BY THE COMMISSION:

On March 15, 2022, Nebraska Metro Transportation, LLC, d/b/a Metro Limousine ("Applicant"), Omaha, filed an application for authority to amend its rates and charges for use in its limousine services. Emergency action was requested.

OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal business address in Omaha, Nebraska. Applicant is a certificated carrier that holds Certificate B-1861 and is authorized to provided transportation to passengers by limousine within and between several Nebraska counties over irregular routes. HHS Designation is no.

Applicant is seeking to amend its existing rates previously granted under Docket B-1861.01r.¹ Applicant seeks to increase its van rate for Omaha to Lincoln/Lincoln to Omaha transfers from a \$200 flat rate to \$285 a flat rate. Applicant also seeks to increase its van rate for Elkhorn, Gretna, Bennington and locations within the vicinity of those areas transfers from a \$180 flat rate to a \$200 flat rate. Applicant proposes to add a Christmas light van tour and a wedding package with a flat rate of a \$360 for two hours of service with an additional hourly cost of \$90. Applicant also seeks to add a directed/open ended van reservation charge of \$270 for the first two hours of service with an additional hourly cost of \$90. Applicant further seeks the addition of an airport transfer charge for the purpose of large events/high demand dates with a flat rate of \$128 for sedans/town cars; \$160 for SUVs; and

\$270 for vans. A review of Applicant's proposed rates finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this Application has Applicant should be placed in a position to offer services for upcoming events in its operating territory. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 29, 2022. Nebraska Metro Transportation, LLC, d/b/a Metro Limousine's complete list of approved rates and charges are attached to this Order as Appendix A.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Nebraska Metro Transportation, LLC, d/b/a Metro Limousine, Omaha, Nebraska be, and it is hereby, authorized to amend its rates for its services effective March 29, 2022, attached hereto as Appendix A.

IT IS FINALLY ORDERED that public notice of this action be published in $\underline{\text{The Daily Record}}$, Omaha, Nebraska, pursuant to the provision of Neb. Rev. Stat. § 75-121 and Commission Rules.
