BY THE COMMISSION:

On March 9, 2022, Prescribed Transportation, LLC ("Applicant"), Omaha, filed an application for authority to establish its rates and charges for its use in its open class operations. Applicant requested approval on an emergency basis.

OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal office in Omaha, Nebraska. On February 8, 2022, Applicant was granted authority to provide transportation to passengers as a common carrier in open class service between points within Douglas and Sarpy counties, and between said counties, over irregular routes. HHS designation is yes.

Applicant is seeking to establish its initial published rates in order to provide transportation services within its service territory. Applicant proposes a per hour flat rate of \$100 for weekdays and \$110 for after-hours/weekends/holidays that includes unlimited miles and unlimited stops. Applicant further proposes a one-way base rate, that includes the first five miles of \$40 for weekdays and \$50 for after-hours/weekends/holidays. Applicant also seeks to implement a round-trip base rate, that includes the first \$75 for weekdays and \$85 miles of for afterhours/weekends/holidays. Applicant's proposed mileage rate is \$2.55 for the weekdays and \$3.22 for after-hours/weekends/holidays beginning at the sixth mile for one-way trips and the eleventh mile for roundtrips. Applicant further proposes a cancellation charge and an additional passenger charge. A review of Applicant's proposed rates finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. In its request, Applicant states that it wants to begin service as soon as possible to avoid any negative financial impacts after initial setup and equipment

expenses. Therefore, the Commission finds that an emergency situation exists that allows the Commission to grant the application on an emergency basis

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted effective March 29, 2022. Applicant's complete list of approved rates and charges are attached to this Order as Appendix A.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Prescribed Transportation, LLC, Omaha, be, and it is hereby, authorized to establish its rates for its services effective March 29, 2022, attached hereto as Appendix A.
