BY THE HEARING OFFICER:

On September 7, 2021, Families and Connections Transporting Services, LLC ("Applicant"), Omaha, Nebraska, filed an application seeking authority as a contract carrier in Nebraska intrastate commerce in the transportation of passengers in open class service within Douglas and Sarpy counties, and between said counties, over irregular routes pursuant to a contract with the Nebraska Department of Health and Human Services, a Medicaid-managed care organization under contract with NDHHS, or another agent working on behalf of NDHHS. HHS Designation is yes. Protests filed by Camelot Transportation, Inc., and Triumph Transportation, Inc. (Collectively "Protestants") were granted on January 20, 2022.

Hearing on this matter was scheduled for April 4, 2022. On April 1, 2022, a conference was held via WebEx with the parties to discuss Applicant's proposed service plans with Commission staff to determine whether Applicant's proposed service would qualify as an exempted service under Neb. Rev. Stat. § 75-303. All parties and Commission staff agreed that postponing the hearing would be preferable to allow for further discussion.

Thus, I find that the hearing originally scheduled for April 4, 2022 should be cancelled to provide additional time for Commission staff to analyze the applicability of possible exemptions.

Additionally, on March 31, 2022, Protestants filed a Motion for Leave to File Witness and Exhibit List Out of Time. I find that the cancellation of the April 4, 2022, hearing renders a decision on the motion unnecessary.
