#### BY THE COMMISSION:

On February 15, 2022, Safe Journeys Transit, LLC ("Applicant"), Omaha, Nebraska, filed an application for authority to establish the initial rates for its transportation services, attached as Appendix A.

Notice of the application was published in The Daily Record, Omaha, Nebraska on March 2, 2022. No protests were filed.

#### OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal business address in Omaha, Nebraska. Applicant was granted authority under Application No. B-2031 to transport passengers and their baggage by sedan and van in open class service between points in Douglas, Sarpy, and Lancaster counties, and between said counties, over irregular routes. HHS designation is yes.

Applicant is seeking to establish its initial rates to be used in its new services. Applicant proposes to charge twenty dollars (\$20.00) for the first five miles, and \$1.76 per mile thereafter. A review of the rates in comparison to other rates charged for comparable services shows the proposed rates to be reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

#### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Safe Journeys Transit, LLC, Omaha, Nebraska, be, and it is hereby, authorized to establish its rates for its services effective April 17, 2022, attached hereto as Appendix A.
