BY THE COMMISSION:

On March 8, 2022, WHC NE, LLC d/b/a Airport Transportation d/b/a My Sedan and zTrip ("Applicant"), Omaha, filed an application for authority to amend its Part C rates by increasing its initial drop charges and mileage fares. Notice of the application was published in The Daily Record, Omaha, on March 18, 2022. No protests were filed.

## O P I N I O N   A N D   F I N D I N G S

Applicant is a Nebraska Limited Liability Company with its principal business address in Omaha, Nebraska. Applicant is a certificated carrier that holds Certificate B-1969, which authorizes, in relevant part, transportation of passengers and their baggage by taxicab between points in Douglas, Lancaster, and Sarpy Counties, and between points in said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes with HHS Designation.

Applicant is seeking to amend its existing Part C rates previously granted under Rate Docket TR-196.<sup>1</sup> In its application, Applicant's initial drop charge for in-town and out-of-town trips would increase from \$2.95 to \$3.50 for the first 1/6<sup>th</sup> mile. Each additional 1/11<sup>th</sup> mile would increase from \$0.20 to \$0.22 for an in-town trip, and out-of-town trip mileage would increase from \$2.25 to \$2.50 per mile. Minimum costs for both in-town and out-of-town trips would be \$6.00. Applicant states that the company has not amended its rates in seven years and needs the increase due to increased costs. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar

services finds that the proposed rates are reasonable. The rates are also reasonable considering the increased expenses Applicant has incurred since the last time it amended its rates. The Commission advises Applicant to examine its rates and apply for more needed increases on a timelier basis to lessen the impact of the increase on the public.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted effective May 1, 2022. The complete list of approved rates and charges are attached as Appendix A.

## O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that WHC NE, LLC d/b/a Airport Transportation d/b/a My Sedan and zTrip, Omaha, Nebraska, be, and is hereby, authorized to amend its rates for its services effective May 1, 2022, as shown in Appendix A.
