#### BY THE COMMISSION:

On April 12, 2022, E Z Cabs, Inc., ("Applicant"), Sioux City, Iowa, filed an application for authority to establish a fuel surcharge in its published rates. Applicant requested approval on an emergency basis.

#### OPINION AND FINDINGS

Applicant is an Iowa corporation with its principal place of business in Sioux City, Iowa. Applicant is a certificate carrier that holds Certificate B-1894, which authorizes the transportation of passengers by taxicab over irregular routes between in points Dakota, Cedar, Dixon, Wayne, Thurston, Cuming, and Burt counties, and between points in said counties. HHS designation is no.

Applicant is seeking to amend its existing rates previously granted under Rate Docket B-1894.01r.¹ Applicant is seeking to establish a fuel surcharge for its South Sioux City zone rates. The surcharge amount ranges from \$2.00 to \$5.00 depending upon the zone. Applicant indicated that it wished to have the surcharge activate when fuel prices are \$2.00 per gallon. The proposed per gallon trigger is too low when considering the purpose of the surcharge is to offset spikes in fuel prices. We therefore find that a trigger of \$3.00 per gallon is more reasonable. Applicant must notify the Commission in writing when its fuel surcharge is implemented and when it is no longer being implemented.²

In applications such as these, the Commission must find that an emergency situation exists. In its request, Applicant states that an increase in its rates are necessary to meet the rising cost of fuel. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective May 10, 2022. E Z Cabs, Inc.'s complete list of approved rates and charges are attached in Appendix A.

#### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that E Z Cabs, Inc., Sioux City, Iowa, be, and is hereby, authorized to amend its rates for its services effective May 10, 2022 as shown in Appendix A.

IT IS FURTHER ORDERED that public notice of this action be published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, pursuant to the provisions of Section 75-121 and Commission Rules.
