BY THE COMMISSION:

On April 11, 2022, Memories Limousine Service, LLC ("Applicant"), Scottsbluff, filed an application for authority to establish the initial rates for its transportation services, attached as Appendix A. Emergency action is requested.

### O P I N I O N   A N D   F I N D I N G S

Applicant is a Nebraska Limited Liability Company with its principal business address in Scottsbluff, Nebraska. Applicant was granted common carrier authority in Docket B-2042 to provide transportation to passengers by luxury or stretch limousine service between points in Scotts Bluff, Sioux, Dawes, Box Butte, Banner, Morrill, and Kimball counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. HHS Designation is no. The authority was granted on December 14, 2021.

Applicant proposes to offer a two-hour rate for its six-passenger and ten-passenger vehicles as well as rates for specific events, such as weddings, birthday parties, and airport service. The proposed rates also include special fees for cleaning and smoking in non-smoking or non-vaping vehicles. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. In its request, Applicant states that it wants to be able to begin offering its services as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that
