O P I N I O N A N D F I N D I N G S

On June 8, 2021, the Commission entered an order granting a suspension of authority for National Health Transport, Inc. ("National Health"), Omaha. The suspension was to end March 31, 2022.

On February 28, 2022, the Transportation Department notified National Health that its suspension period was ending soon. On March 29, 2022, a letter was sent to National Health stating that the suspension period expired, and that action must be taken or the carrier would face Commission action. Department staff attempted to contact National Health on multiple occasions, but the carrier remains unresponsive. To date, National Health has failed to take the appropriate actions to reactivate its authority.

After due consideration of the circumstances, the Commission finds that National Health Transport, Inc., Omaha, should be ordered to show cause why its Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked in whole or in part for failure to reactivate its authority after the expiration of its voluntary suspension. Therefore, hearing on this matter shall be held on **Wednesday, June 29, 2022**, at **1:00 p.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska. O R D E R


