O P I N I O N A N D F I N D I N G S

On June 8, 2021, the Commission entered an order granting a suspension of authority for Nebraska Excellent Health Transportation Services ("Excellent Health"), Omaha. The suspension was to end February 28, 2022.

On January 31, 2022, the Transportation Department notified Excellent Health that its suspension period was ending soon. On February 28, 2022, a letter was sent to Excellent Health stating that the suspension period expired, and that action must be taken or the carrier would face Commission action. Department staff attempted to contact Excellent Health on multiple occasions, but the carrier remains unresponsive. To date, Excellent Health has failed to take the appropriate actions to reactivate its authority.

After due consideration of the circumstances, the Commission finds that Nebraska Excellent Health Transportation Services, Omaha, should be ordered to show cause why its Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked in whole or in part for failure to reactivate its authority after the expiration of its voluntary suspension. Therefore, hearing on this matter shall be held on **Wednesday, June 29, 2022, at 1:30 p.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska. O R D E R


