On February 2, 2022, Robert F. Paup, d/b/a Tri City Ride ("Applicant"), Grand Island, Nebraska, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by sedan, coupe, van and pickup in taxicab service between points in Hall, Adams, Buffalo, York, Lancaster, Dodge, Lincoln, Keith, Scotts Bluff, Platte, and Seward counties, and between said counties, over irregular routes. HHS designation is no.

Notice of the Application was published in The Daily Record, Omaha, Nebraska, on February 9, 2022. The Application was protested by Comstock Corporation d/b/a Action Cab. A Hearing in this application was scheduled for June 1, 2022. On May 5, 2022, Applicant contacted the Commission requesting to withdraw their application.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds:

1. The request should be granted.
2. Application No. B-2048 should be withdrawn.

O R D E R


