BY THE COMMISSION:

On May 13, 2022, Abundis Mora, LLC d/b/a Tabella Party Bus, LLC ("Applicant"), Bellevue, filed an application for authority to establish its initial rates and charges for its new services. Emergency action is requested.

OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal business address in Bellevue, Nebraska. Applicant is a certified carrier that holds Certificate B-2051, which authorizes transporting passengers by bus in special party service between points in Douglas, Sarpy, Saunders, Lancaster, Dodge, Washington, and Cass counties, and between said counties, over irregular routes. HHS Designation is no.

Applicant is seeking to establish its initial rates and charges to be used in its new services. Applicant proposes a rate of \$12.50 per person, per hour. Trips would be scheduled with a minimum of fourteen people and two hours. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services show that the proposed rates are reasonable.

In applications such as these, the Commission must determine whether an emergency situation exists. Such a situation exists in this application, as Applicant has indicated that it is already receiving inquiries for services and wants to be able to provide transportation as soon as possible. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective
