O P I N I O N A N D F I N D I N G S

On April 12, 2022, the Nebraska Public Service Commission ("Commission") received a Form K Insurance Cancellation Notice for Kearney Cab Company, LLC d/b/a Kearney Cab Company ("Kearney Cab"), Kearney, who holds a Certificate of Public Convenience and Necessity under Certificate No. B-1402. The Form K received from National Continental Insurance Company had a cancellation date of May 3, 2022.

Pursuant to Commission Rule 006, all carriers are required to file documents with the Commission that show proof of current insurance meeting the minimum insurance requirements. On April 12, 2022, Kearney Cab was notified via letter of the cancellation notice. On May 4, 2022, the Commission sent a second letter to Kearney Cab informing them to cease and desist all operation until a new insurance policy was in force. To date, the Commission has not received a current Form E Insurance filing.

After due consideration of the circumstances, the Commission finds that Kearney Cab Company, LLC d/b/a Kearney Cab Company, Kearney, should be ordered to show cause as to why is Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked in whole or in part, for failure to maintain required liability insurance and provide proof of such insurance to the Commission in accordance with Commission Rule 006. Therefore, hearing on this matter shall be held on **Wednesday, July 26, 2022, at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
