On February 28, 2022, Mike's Handy Van, LLC ("Applicant"), Lincoln, Nebraska, filed an application seeking authority to extend its common carrier authority to transport passengers by van, sedan, and electric vehicle in open class statewide. HHS Designation is yes. Applicant also seeks recognition of a name change to Safe & Reliable Transportation Services. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on March 11, 2022.

On March 23, 2022, a timely protest by Camelot Transportation, Inc. and Triumph Transportation, Inc. (together, "Protestants").

On May 24, 2022 the Hearing Officer entered an Order which granted the Protests of the Protestants.
