BY THE COMMISSION:

By order entered November 8, 2000, this Commission suspended the authority granted to Star Limousine, Inc., (Star Limo) of Omaha, Nebraska in Application No. B-1259. In that Order, the Commission held that Star Limo had ninety days to provide the Commission with documented proof that the following conditions have been met:

1. Star Limo was to provide restitution to named persons who filed complaints with the Commission and showed that they were charged for limousine service they did not receive;
2. Star Limo was to demonstrate that it had adequate insurance coverage through an alternative insurance provider;
3. Star Limo was to submit its vehicles to periodic inspections at the discretion of the Commission; and
4. Star Limo was to post a bond in the amount of \$5,000 to cover complaints not registered with the Commission at the time of the hearing.

On December 6, 2000, we received an application by R & F Hobbies, Inc. dba Prince of the Road, requesting that we approve the proposed purchase and transfer of Star Limo's certificate of convenience and necessity (Application No. B-1441 Supp. 1). Hearings were held on a request by Prince of the Road for temporary authority on December 28, 2000, and on the matter of permanent authority on February 8, 2001. On February 20, 2001, Prince of the Road withdrew its application in Application No. B-1441 Supp. 1.

While Application No. B-1441 Supp. 1 was pending, we did not take further action in the above-captioned matter. Now that Prince of the Road has withdrawn its application, we find it is necessary

to move forward promptly on our commitment to reopen this matter to determine what efforts, if any, Star Limo has made to fulfill the obligations we imposed.

We note that, as of the date of this order, Star Limo has not demonstrated to the Commission in this proceeding that the aforementioned conditions have been met. Accordingly, we enter this order directing Star Limo to show cause why its certificate of public convenience and necessity should not be fully revoked. We find Star Limo has until March 21, 2001, to demonstrate to the Commission that the conditions we imposed in our November 8, 2000, Order have been met.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Star Limousine, Inc., of Omaha, Nebraska, is hereby ordered to show cause why the Commission should not revoke Star Limousine, Inc.'s certificate of Public Convenience and Necessity.

IT IS FURTHER ORDERED that Star Limousine, Inc., personally appear before this Commission at a hearing in this matter in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska, on March 21, 2001, at 10:00 a.m.

IT IS FURTHER ORDERED that until Star Limousine, Inc., has shown cause why its certificate should not be revoked, its certificate remains suspended pursuant to the Commission's order of November 8, 2000.
