## OPINION AND FINDINGS

By application filed March 10, 1995, applicant Mayflower Contract Services, Inc., Overland Park, Kansas, seeks approval for a change in control pursuant to a transfer of stock ownership. Applicant operates as a motor common carrier of passengers pursuant to authority issued in Certificate B-1275.

Notice of the application in caption was published in <u>The Daily Record</u>, Omaha, Nebraska, on March 15, 1995, pursuant to the rules of the Commission.

Since no protest was filed, Application B-1275, Supplement 1 was processed pursuant to Rule 018.03 of the rules of the Commission.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

- That applicant is fit, willing, and able to properly perform the service proposed and will be so qualified after the proposed change in stock control is effected.
- 2. That the change in stock control resulting from the proposed transfer of stock is consistent with the public interest and does not unduly restrict competition.
- 3. That a change in control of applicant pursuant to a transfer of all the issued and outstanding stock of Mayflower Contract Services, Inc. should be approved.

## ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Application B-1275, Supplement 1 for approval of a change in control of applicant pursuant to the transfer of stock be, and it is hereby, approved.

IT IS FURTHER ORDERED that the approval herein granted shall be subject to such terms, conditions and limitations which have been or may hereafter be prescribed by the Commission.
