BY THE COMMISSION:

On March 30, 2005, Brian L. Mills dba Fantasy Limousine requested suspension until April 1, 2005. Defendant was contacted by Mark Breiner, Director of Motor Transportation, concerning compliance with the Public Service Commission Rules and Regulations. An Order to Show Cause and Set Hearing was entered on May 25, 2005, and the hearing was held on June 7, 2005. Mr. Mills was present and was granted the opportunity to file a third request for a suspension or file Form E insurance, and acquire plates.

By show cause order entered August 30, 2005, this Commission ordered Brian L. Mills dba Fantasy Limousine, Omaha, Nebraska, to demonstrate why its certificate of public convenience and necessity should not be revoked.

Notice was sent to Brian Mills by certified mail on August 30, 2005. Records with the United States Post Office showed that as of September 7, 2005, Mr. Mills had been notified that a certified letter was waiting to be picked up but that he had not yet done so.

A hearing on the matter was held on September 7, 2005, in the Commission Hearing Room, Lincoln, Nebraska. Mr. Brian L. Mills, Defendant, did not enter a personal appearance at the hearing. Mark Breiner appeared on behalf of the Commission staff.

The Commission did review the case file and records in the matter. The Commission finds that Mr. Mills has been given ample opportunity to get his authority in good standing with the Commission, but has failed to either file the appropriate forms and fees or to file a request for an additional suspension.

The Commission did receive, via hand delivery to Robert Harrison by Joseph Higgins, an equipment lease agreement dated August 9, 2005, with a check for a PSC plate in the amount of \$50 dated September 9, 2005. This Agreement does not, however, obviate the need for a Form E to be on file with the Commission. As there is no Form E on file for either party, the Agreement is of no effect on this matter.

As of September 12, 2005, the Defendant is not in compliance with Commission rules and regulations; to wit, no Form E insurance has been filed and no annual fees paid. A request for suspension has not been received.

The Commission is of the opinion and finds that the authority held by Mr. Brian L. Mills dba Fantasy Limousine, Omaha, Nebraska, can and should be revoked for failure to have a Form E on file, and for not paying its annual fees, and/or for failure to file a request for suspension in a timely manner.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the show cause be sustained and the authority granted to Brian L. Mills dba Fantasy Limousine, Omaha, Nebraska, in B-1277, shall be, and it is hereby revoked.


