OPINION AND FINDINGS

By application filed January 17, 1992, Limo One, Inc., dba Old Market Limousine, Papillion, Nebraska, seeks to acquire, through purchase, the operating rights granted to Old Market Limousine Service, Inc. in Certificate of Public Convenience and Necessity issued in Application B-1167.

AUTHORITY SOUGHT

Passengers and their baggage in luxury or stretch limousines, or service in antique or classical automobiles between points in Omaha, Nebraska, and between points in Omaha, Nebraska, on the one hand, and, on the other hand, points throughout the State of Nebraska.

Notice of the application was published in The Daily Record, Omaha, Nebraska on January 22, 1992, pursuant to the rules of the Commission.

Protest was filed by Inn "X" Press, Inc., but on April 17, 1992, it was withdrawn, Application B-1322, was then processed pursuant to Rule 018.03 of the rules of the Commission.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed service.
2. The proposed transfer of operating rights will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1167, is not dormant.
4. A certificate should be issued in Application B-1322 authorizing the following operations:

CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

Passengers and their baggage in luxury or stretch limousines, or service in antique or classical automobiles between points in Omaha, and between points in Omaha, on the one hand, and, on the other hand, points in Nebraska.

5. The certificate issued in Application B-1167 should be revoked and cancelled.

O R D E R

IT IS THEREFORE, ORDERED, by the Nebraska Public Service Commission that Application B-1322 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Limo One, Inc., dba Old Market Limousine, Papillion, Nebraska, in Application B-1322, authorizing the operations set forth in Paragraph No. 4 of the foregoing findings; and that to avoid a lapse in authority, the Certificate of Public Convenience and Necessity issued in Application B-1167, shall be revoked and cancelled simultaneously with the issuance of a Certificate of Public Convenience and Necessity in Application B-1322.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with Sections 75-305 (fees), 75-307 (insurance), and 75-308 (rates), R.R.S. 1943, as amended, and with the rules and regulations of the Commission; and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.


IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.


