# BY THE COMMISSION:

On December 12, 2000, the Commission granted the application of Midwest Special Services, Inc., Curtis, Nebraska, ("Applicant") seeking to acquire, through transfer, the authority granted to Karibu Enterprises, Inc., dba RT Round Trip Transport ("Round Trip") in Certificate B-1395. The certificate in B-1395 authorized Round Trip to operate as a carrier in Nebraska intrastate commerce in the transportation of passengers and their baggage by passenger van and sport utility vehicles, fifteen (15) passengers or less, between points in Nebraska over irregular routes. The certificate was restricted against the transportation of railroad train crews and their baggage.

In the language describing the authority granted, language was inadvertently omitted which describes the geographic area covered by the grant of authority. We find that this order should be entered to correct the order of December 12, 2000 in this respect and to make clear the authority granted. Therefore we find that the authority granted to the Applicant should read,

#### CERTIFICATE AUTHORIZED

## SERVICE AND TERRITORY TRANSFERRED AND AUTHORIZED:

Passengers and their baggage in vans or sport utility vehicles rated at fifteen (15) passengers or less who have arranged for service at least six hours in advance, except for passengers to and from Eppley Airfield who shall arrange for service at least twelve (12) hours in advance between points in Nebraska over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage are not authorized.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that an Order Nunc Pro Tunc should be entered in Application B-1351, Supplement No. 2, to include the language inadvertently omitted in the original description of the

certificate authorized.

IT IS FURTHER ORDERED that all other conditions and orders entered by this Commission on December 12, 2000 not otherwise affected by this order shall be, and remain, in full force.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued which is consistent with our findings in this order and in the order issued in this docket on December 12, 2000.

IT IS FURTHER ORDERED that the Certificate of Public Convenience and Necessity authorized shall be subject to the terms, conditions, limitations and restrictions which have been, or may hereafter be, prescribed by the Commission.
