On August 17, 2018, the Commission received a Form K Insurance Cancellation Notice for Dashabout Roadrunner, Inc., Akron, Colorado, who holds a Certificate of Public Convenience and Necessity under Certificate No. B-1375. The Form K received from National Casualty Company had a cancellation date of September 21, 2018. Dashabout Roadrunner was notified by letter and telephone of the cancellation notice. To date, the Commission has not received any communication or a current Form E insurance filing.

Pursuant to Commission Rule 006, all carriers are required to file documents with the Commission that show proof of current insurance that meets the minimum insurance requirements.

After due consideration of the circumstances, the Commission finds that Dashabout Roadrunner, Inc., Akron, Colorado, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure to keep a current Form E insurance filing with the Commission in accordance with Commission Rule 006. Therefore, hearing on this matter shall be held on **Wednesday, January 23, 2019, at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
