BY THE COMMISSION:

On December 14, 2016, an application was filed by Daniel W. and Susan L. Sindt d/b/a Kearney Cab Company ("Applicant"), Kearney, seeking a change in organization to Kearney Cab Company, LLC. Notice of the application was published in The Daily Record, Omaha, on December 16, 2016. Due to an administrative error, the application was noticed as a name change instead of a change in organization. A new notice was published in The Daily Record on January 27, 2017. No protests were filed; therefore, the application will be processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant operates as a taxicab company with a certificate of public convenience and necessity under Certificate No. B-1402. In its application, Applicant seeks an order from the Commission approving an organizational change from an individual to an LLC named Kearney Cab Company, LLC. Applicant has applied for and has been granted a Certificate of Organization as a limited liability company duly organized and existing under and by the virtue of the laws of the State of Nebraska. The principal place of business remains in Kearney, Nebraska, and will retain its current location as its business headquarters.

Upon consideration of Applicant's filing and the files and records of the Commission relative to Applicant and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able to continue to perform its current services.
2. The proposed change of organization will be consistent with the public interest and will not unduly restrict competition.
3. The authority held by Applicant should be carried in the files of the Commission in the new name of the Applicant to wit: Kearney Cab Company, LLC d/b/a Kearney Cab Company, Kearney,
