OPINION AND FINDINGS

By application filed December 13, 1995, Gerald L. Andre, dba Taxicab Service of La Placita, Lexington, Nebraska, hereinafter referred to as applicant, seeks approval of the acquisition of the operating rights and authority granted to Robert L. Meyer, dba Bob's Taxi in Certificate B-1229 which authorizes:

SERVICE AND TERRITORY AUTHORIZED:

Passengers and their baggage by taxicab between points in Lexington and vicinity over irregular routes.

In its application, applicant further requested that this Commission grant temporary approval to the applicant of a lease of the motor carrier properties and the certificate sought to be acquired by it. Notice of such request for temporary authority was published in The Daily Record, Omaha, Nebraska, on December 14, 1995, pursuant to the rules and regulations of this Commission.

It appears that failure to grant temporary approval may result in destruction of or injury to such motor carrier property and the certificate sought to be acquired, or interfere substantially with their future usefulness in the performance of adequate and continuous service to the public.

Such temporary approval should be granted for ninety (90) days from the effective date of this Order pursuant to 75-319, R.R.S. 1943, as amended.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that the application for approval of a lease of the motor carrier properties and the certificate sought to be acquired by Gerald L. Andre, dba Taxicab Service of La Placita be, and it is hereby, granted to the applicant for ninety (90) days from the effective date of this Order.

IT IS FURTHER ORDERED that transportation service rendered under such temporary authority shall be subject to the provisions of 75-101 to 75-801, R.R.S. 1943, as amended, and to the rules, regulations and requirements of the Commission; such grant of
