OPINION AND FINDINGS

By application filed April 17, 2007, Yellow Cab & Limo, Inc., Beatrice, hereinafter referred to as applicant, seeks a Permit to operate as a common carrier of passengers by motor vehicle as follows:

AUTHORITY SOUGHT

SUPPLEMENT 6:

Transportation of passengers and their baggage in open class service as a contract carrier for Advance Services, Beatrice, by vans between points in Gage County and Lancaster County, and between points in said counties.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on April 23, 2007, pursuant to the rules of the Commission.

On May 10, 2007, a protest was filed by Prince of the Road, through its attorney, John Boehm, and on May 23, 2007, VIP Limobus, LLC. On July 6, 2007, a restrictive amendment was filed by Yellow Cab & Limo, Inc., through its attorney, Stephanie L. Clark. On June 20, 2007, the protest of VIP Limobus, LLC, was withdrawn, and on July 19, 2007, the protest of Prince of the Road was withdrawn. Application B-1434, Supplement 6, was then processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed service, and to conform to the provisions of Neb. Rev. Stat., sections 75-301 to 75-322.04, (Reissue 2003), and the requirements, rules and regulations of the Commission thereunder.
2. The proposed intrastate service is or will be required by the following extent:

PERMIT AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

SUPPLEMENT 6:

Transportation of passengers and their baggage in open class service as a contract carrier to provide service to Advance Services, Beatrice, Nebraska, by vans between points in Gage County and Lancaster County, and between points in said counties.

3. The application for authority should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1434, Supplement 6, be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Permit shall be issued to Yellow Cab & Limo, Inc., in Application B-1434, Supplement 6.

IT IS FURTHER ORDERED that applicant shall not be issued the Permit authorized by the Commission unless and until applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat. sections 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Reissue 2003), and with the rules and regulations of the Commission, and if upon expiration of such time applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.

IT IS FURTHER ORDERED that applicant shall not conduct operations until a Permit is issued.
