OPINION AND FINDINGS

By application filed September 3, 2014, Transport Plus of Lincoln dba Transport Plus, Lincoln, seeks to change an existing operation by the transfer of stock ownership.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on September 8, 2014, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1439 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Transport Plus of Lincoln dba Transport Plus, Lincoln, is a corporation duly organized and existing under and by the virtue of the laws of the state of Nebraska, with its principal place of business being in Lincoln, Nebraska. The business headquarters of Transport Plus of Lincoln dba Transport Plus, Lincoln, will remain in its current location in Lincoln, Nebraska, if the transfer of the stock of Transport Plus of Lincoln dba Transport Plus is approved by the Commission. Applicant is in the business of providing transportation services by van. The Applicant currently provides services in Lancaster County, and between points within said county on the one hand, and, on the other hand, points in Nebraska over irregular routes. The Applicant will continue to provide the same service.

As the matter was not protested, it proceeded on a modified basis.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed change of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1575 is not dormant.
4. An order should be entered in Application B-1439 authorizing Transport Plus of Lincoln dba Transport Plus, Lincoln, to change an existing operation by the transfer of stock ownership.

ORDER



