## OPINION AND FINDINGS

By application filed March 16, 2009, R & F Hobbies, Inc., dba Prince of the Road, Ravenna, seeks to transfer fifty-one (51%) of the stock of R & F Hobbies, Inc., dba Price of the Road, to James F. Laudenklos through purchase of stock

Notice of the application was published in the Daily Record, Omaha, Nebraska, on April 2, 2009, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1441 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

R & F Hobbies, Inc., dba Prince of the Road is a corporation duly organized and existing under and by the virtue of the laws of the state of Nebraska, with its principal place of business being in Ravenna, Nebraska. The business headquarters of R & F Hobbies, Inc., dba Prince of the Road will remain in its current location in Ravenna, Nebraska, if the transfer of the stock of Prince of the Road is approved by the Commission. Applicant is in the business of providing transportation services. The applicant will continue to provide the same service as before.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed acquisition of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1441 is not dormant.

4. An order should be entered in Application B-1441 authorizing James F. Laudenklos to acquire control of R & F Hobbies, Inc., dba Prince of the Road through purchase of stock.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1441, be, and it is hereby, granted; and that James F. Laudenklos, is hereby authorized to acquire control of R & F Hobbies, Inc., dba Prince of the Road, through purchase of stock as proposed by its application.

IT IS FURTHER ORDERED that following consummation of the transaction hereby authorized, James F. Laudenklos shall cause the operations of R & F Hobbies, Inc., dba Prince of the Road, to continue to be conducted under Certificate B-1441.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.


