## OPINION AND FINDINGS

On March 14, 2002, the Commission received a Form K Insurance Cancellation Notice on Walter Fowler dba Luxor Limousine, Bellevue, Nebraska, Nebraska, who is a registered intrastate carrier with the Commission. The Form K Insurance Cancellation Notice was received from Columbia Insurance Company with a cancellation date of April 17, 2002. The carrier was notified by letter of the cancellation of its insurance and attempts were made by John Schmidt, Motor Transportation Rate Analyst, to notify the carrier also. However, to date, the Commission has not received a current Form E insurance filing for Walter Fowler dba Luxor Limousine.

After due consideration of the circumstances, the Commission finds that Walter Fowler dba Luxor Limousine, Bellevue, Nebraska, should be ordered to show cause on or before May 22, 2002, why its intrastate certificate should not be revoked for failure to keep a current Form E insurance filing on file with the Commission. If no filing has been received by the Commission on or before May 22, 2002, a revocation hearing will be held on May 23, 2002 at 11:00 a.m. in the Commission Hearing Room, Lincoln, Nebraska.

In addition, the Commission finds the authority granted to Walter Fowler dba Luxor Limousine has lapsed by operation of law under Neb. Rev. Stat. § 75-307. Therefore, the Commission finds Walter Fowler dba Luxor Limousine should immediately cease operations until the Commission is satisfied that the requirements of Neb. Admin. R. & Regs. Title 291, Ch. 3, Section 006 and state law have been met.

## ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Walter Fowler dba Luxor Limousine, Bellevue, Nebraska, be, and it is hereby, ordered to show cause on or before May 22, 2002, why its intrastate certificate should not be revoked for failure to keep a current Form E insurance filing on file with the Commission.

IT IS FURTHER ORDERED that a revocation hearing be held on May 23, 2002 at 11:00 a.m., in the Commission Hearing Room, Lincoln, Nebraska.

IT IS FURTHER ORDERED that since the authority granted to Walter Fowler dba Luxor Limousine, Bellevue has lapsed by operation of law, Walter Fowler dba Luxor Limousine shall immediately cease all operations until further notice by this Commission as provided herein.
