OPINION AND FINDINGS

By application filed October 20, 1997, Beverly S. Denman, dba 80-Taxi Line, Hastings, Nebraska, hereinafter referred to as applicant, seeks approval of the acquisition of the operating rights and authority granted to Gale Klawonn, dba 80-Taxi Line in Certificate B-1247 which authorizes:

SERVICE AND TERRITORY AUTHORIZED:

(A) Taxicab operations within Hastings and vicinity; and (B) Limousine service between the Clarke Hotel, 3rd and Hastings Avenue, Hastings, and the terminal building at Grand Island Airport, Grand Island, and return.

In its application, applicant further requested that this Commission grant temporary approval to the applicant of a lease of the motor carrier properties and the certificate sought to be acquired by it. Notice of such request for temporary authority was published in The Daily Record, Omaha, Nebraska, on October 21, 1997, pursuant to the rules and regulations of this Commission.

It appears that failure to grant temporary approval may result in destruction of or injury to such motor carrier property and the certificate sought to be acquired, or interfere substantially with their future usefulness in the performance of adequate and continuous service to the public.

Such temporary approval should be granted for ninety (90) days from the effective date of this Order pursuant to §75-319, R.R.S. 1943, as amended.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that the application for approval of a lease of the motor carrier properties and the certificate sought to be acquired by Beverly S. Denman, dba 80-Taxi Line be, and it is hereby, granted to the applicant for ninety (90) days from the effective date of this Order.
