OPINION AND FINDINGS

By application filed with the Commission on May 12, 1998, Visinet, Inc., Omaha, Nebraska, Nebraska, hereinafter referred to as applicant, was issued a Certificate of Public Convenience and Necessity in Application B-1472. An order was entered, at applicant's request, on April 27, 2010, suspending applicant's certificate until April 30, 2011. Applicant was informed that its authority is no longer in suspension and that it must make full compliance with the Commission's rules and regulations.

As of June 1, 2011, applicant is still not in full compliance with the Commission's rules and regulations; to wit: No Form E insurance filing has been made and no annual fees have been paid.

After due consideration of the circumstances, the Commission finds that applicant should be ordered to show cause on or before June 10, 2011, why its certificate should not be revoked for its failure to comply with the Motor Carrier Rules of the Commission.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Visinet, Inc., Omaha, Nebraska, be, and it is hereby ordered to show cause why its Certificate of Public Convenience and Necessity should not be revoked for failure to comply with Commission rules on or before June 10, 2011, and a hearing was set for June 21, 2011, at 1:30 p.m., 2011, in the Commission Hearing Room, Lincoln.
