OPINION AND FINDINGS

It was brought to the Commission's attention that an order nunc pro tunc should be entered to correctly reflect the authority granted by the Commission in the application of Comstock Corporation dba Action Cab, Grand Island, seeking to acquire, through transfer, the authority granted in Certificate B-1507, Supplement 1, to Hastings Taxi and Transportation Services, L.L.C., Hastings. The Commission has reviewed the files and records of the Commission and finds that a portion of the authority granted in the order of December 21, 2000, to Comstock Corporation dba Action Cab was inadvertently left in the authority granted to Hastings Taxi and Transportation Services, L.L.C., Hastings. The purpose of an order nunc pro tunc is to correct the record which has been made so that it will truly record the action taken which, through inadvertence or mistake, was not truly recorded. Interstate Printing Co. v. Dept. of Revenue, 236 Neb. 110, 459 N.W.2d 529 (1990). Clerical errors may be corrected by an order nunc pro tunc, but not judicial errors. Larson v. Bedke, 211 Neb. 247, 318 N.W.2d 253 (1982).

From the evidence adduced in these proceedings and being fully informed in the premises the Commission is of the opinion and finds that:

- 1. The order entered herein on December 21, 2000, should be corrected nunc pro tunc.
- 2. The authority should read as follows for Hastings Taxi and Transportation Services, L.L.C.:

SERVICE AND TERRITORY AUTHORIZED:
COMMON: (A) Taxicab operations within Hastings and vicinity;
(B) operating limousine service between the Clarke Hotel, 3rd and Hastings Avenue, Hastings, and the terminal building at Grand Island Airport, Grand Island, and return.
