BY THE COMMISSION:

On May 10, 2000, this Commission received a Petition for Investigation and Request for Hearing by Chauffeurs To Go, Omaha, Nebraska ("Petitioner") through their attorney, Charles J. Headley. Petitioner requests a determination as to whether the scope of the Commission extends to a proposed enterprise in which the Petitioner would provide, at a fee, drivers to operate the vehicles of potential clients. The Petitioner would not possess or own any vehicles themselves, but would provide only driving services. Petitioner requests a ruling as to whether such proposed operation would meet the statutory definition of "common carrier" as defined in Neb. Rev. Stat. § 75-302(5).

The Commission finds that the Motion for Investigation and Hearing should be granted. The Commission finds that for purposes of public notice and for administrative ease that the best mechanism for this investigation is to open a docket on the motion. The Commission also finds that a hearing should be set on this matter.

This docket is therefore opened to investigate the following areas:

- 1) Whether the proposed service of offering driver service to the public by an enterprise which possesses nor owns any vehicles of its own is subject to Commission jurisdiction;
- Whether such an enterprise constitutes a "common carrier" as defined by law; and,
- 3) Other issues the Commission deems to be relevant to such proceedings.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Motion by Chauffeurs To Go for an Investigation and a Hearing should be, and is hereby, granted.

IT IS FURTHER ORDERED by the Nebraska Public Service Commission that an investigation be commenced on the above listed issues regarding the jurisdiction of the Commission over a proposed enterprise which would provide only driver services to the public and all relevant issues as described herein and that this docket shall serve as the administrative vehicle for the entertainment of Petitioner's granted motions.

IT IS FURTHER ORDERED that a hearing should be scheduled as soon as can be agreed upon by the Petitioner and the Commission.

IT IS FURTHER ORDERED that the Commission issue findings as well as any reasonable recommendations at the conclusion of this investigation.
