OPINION AND FINDINGS

By application filed June 19, 2000, Ronald Clark and Allen Clark dba Limo de Luxe, McCool Junction, hereinafter referred to as applicant, seeks approval of the acquisition of the operating rights and authority granted to Welch Implement Company in Certificate B-1400 which authorizes:

SERVICE AND TERRITORY AUTHORIZED:

COMMON: Passengers and their baggage by limousine between origin points in Polk and York Counties, on the one hand, and, on the other hand, points in Polk, York, Merrick, Butler, Platte, Hamilton, Hall, Seward, Lancaster and Douglas Counties over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.

In its application, applicant further requested that this Commission grant temporary approval to the applicant of a lease of the motor carrier properties and the certificate sought to be acquired by it. Notice of such request for temporary authority was published in The Daily Record, Omaha, Nebraska, on June 20, 2000, pursuant to the rules and regulations of this Commission.

It appears that failure to grant temporary approval may result in destruction of or injury to such motor carrier property and the permit sought to be acquired, or interfere substantially with their future usefulness in the performance of adequate and continuous service to the public.

Such temporary approval should be granted for ninety (90) days from the effective date of this Order pursuant to Neb. Rev. Stat., Section 75-319 (Reissue 1996).

O R D E R

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that the application for approval of a lease of the motor carrier properties and the certificate sought to be acquired by Ronald Clark and Allen Clark dba Limo de Luxe be, and it is hereby, granted to the applicant for ninety (90) days from the effective date of this Order.



Stat., Section 75-101 and 75-802, (Reissue 1996), and to the rules, regulations and requirements of the Commission; such grant of temporary authority and the operations thereunder shall not be admissible in evidence to establish or prove present or future public convenience and necessity; and no renewal or extension of the period of ninety (90) days shall be granted.


