OPINION AND FINDINGS

By application filed March 27, 2013, Golden Plains Services, LLC, dba High Plains Cab Service, McCook, seeks to change an existing operation by the transfer of stock ownership.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on March 29, 2013, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1575 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Golden Plains Services, LLC, dba High Plains Cab Service, is a limited liability corporation duly organized and existing under and by the virtue of the laws of the state of Nebraska, with its principal place of business being in McCook, Nebraska. The business headquarters of Golden Plains Services, LLC, dba High Plains Cab Service will remain in its current location in McCook, Nebraska, if the transfer of the stock of High Plains is approved by the Commission. Applicant is in the business of providing transportation services by taxicab. The Applicant currently provides services in Red Willow, Hitchcock, Hayes, Dundy, Chase, Frontier, Furnas and Gosper counties and between points within said counties on the one hand, and, on the other hand, points in Nebraska over irregular routes. The Applicant will continue to provide the same service.

As the matter was not protested, it proceeded on a modified basis.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed change of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1575 is not dormant.
4. An order should be entered in Application B-1575 authorizing Golden Plains Services, LLC, dba High Plains Cab Service, McCook, to change an existing operation by the transfer of stock ownership.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1575, be, and it is hereby, granted; and that Golden Plains Services, LLC, dba High Plains Cab Service, McCook, is hereby authorized to change its existing operation by the transfer of stock ownership as follows: Marlan V. Dooley (100%).

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
