OPINION AND FINDINGS

By application filed November 18, 2002, Angel Vazquez dba El Aquila Transportation (El Aquila), of Lexington, Nebraska, hereinafter referred to as applicant, seeks a Certificate of Public Convenience and Necessity to operate as a common carrier of passengers by motor vehicle as follows:

Common: Transportation of passengers and their baggage in Nebraska intrastate commerce by van in open class service over regular and irregular routes between points in Lexington over regular routes and between points within a 40-mile radius of Lexington over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. The transportation of clients of the Nebraska Department of Health and Human Services and subcontractors thereof is not permitted.

No protests to the application were filed. The Commission held a hearing on the application on April 9, 2003, in the Commission Hearing Room. On July 15, 2003, the Commission granted the above-captioned application.

In the order granting the above-captioned application, the Commission directed El Aquila to comply, within 90 days from the effective date of that Order, with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Reissue 1996), and with the rules and regulations of the Commission. The Order further provided that if upon expiration of such time applicant has not complied with such terms and conditions, the granting

order shall, after reasonable notice to applicant, be of no further force and effect.

On October 14, 2003, El Aquila filed a letter with the Commission requesting additional time to file its insurance documentation, its fees and a rate application with the Commission. El Aquila asked for an additional two months. Upon consideration of this request, the Commission is of the opinion and finds that El Aquila's request should be granted. El Aquila should have until December 15, 2003 in which to comply with Neb. Rev. Stat. §§ 75-305, 75-308 and 75-309, and with the rules and regulations of the Commission.

O R D E R




IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that El Aquila's request for an extension of time to comply with Neb. Rev. Stat. §§ 75-305, 75-308 and 75-309 and with the rules and regulations of the Commission shall be and it is hereby granted.

IT IS FURTHER ORDERED that El Aquila shall have until December 15, 2003 to be in compliance with the applicable statutes, and the rules and regulations of the Commission provided herein and if upon expiration of such time applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.
