OPINION AND FINDINGS

By application filed August 11, 2003, Rick Holloway dba Taxi Specialties of Lexington, Lexington, Nebraska hereinafter referred to as applicant, seeks approval to utilize four door vans instead of sedans for use as taxicabs in applicant's passenger transportation service. Applicant seeks the use of said equipment to have more room and make it more comfortable for its clients.

On August 26, 2003, the application for waiver was published in the Daily Record, Omaha, Nebraska. There were no objections filed to this application. Through its application and affidavit, the applicant has made the requisite showing that a different vehicle will serve as well or better in accordance with Rule 11.01D, Chapter 3, Title 291.

Through its application, Applicant caused its authority to be modified. Due to the modification, the Commission has restated Applicant's authority.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds that:

- 1. Application should be granted and Applicant should be permitted to use vans in its fleet.
- 2. Applicant's authority should be restated to read
 as follows:

CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED: COMMON: Transportation of passengers in Nebraska intrastate commerce in taxicab service by sedans and vans between points in the city of Lexington and between points in Lexington and points in Nebraska over irregular routes to include the transportation of clients of the Nebraska Department of Health and Human Services. RESTRICTION: transportation of Health and Human Services clients and all subcontractors, organizations and companies involving Health and Human Services client transportation is to be restricted to within a ten (10) mile radius of Lexington, Nebraska. No transportation of said clients in or out of this area is authorized. The transportation of railroad train crews and their baggage is not authorized. Transportation of multiple passengers by van on a scheduled basis or regular route is not authorized.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that the application for approval of the use of the vans to the applicant's taxicab fleet is hereby granted as modified as provided herein.

IT IS FURTHER ORDERED that Rule 011.01D, Chapter 3, Title 291 is hereby waived with respect to Rick Holloway dba Taxi Specialties of Lexington's application for approval to institute the use of vans to its passenger transportation service in part as provided herein.

IT IS FURTHER ORDERED that a revised Certificate of Public Convenience and Necessity shall be issued to Rick Holloway dba Taxi Specialties of Lexington, Lexington, Nebraska, in Application No. B-1613, authorizing the operations set forth in the foregoing findings.
