## OPINION AND FINDINGS

By application filed with the Commission on December 11, 2002, Rick Holloway dba Taxi Specialties of Lexington, Lexington, Nebraska, hereinafter referred to as applicant, was issued a Certificate of Public Convenience and Necessity in Application B-1613.

On August 18, 2006, Taxi Specialties of Lexington was contacted by Commission investigators to provide transportation in Lexington. The investigators were advised that a cab would pick them up in 15 minutes. Approximately 15 minutes after that call, a gray Chrysler Sebring sedan drove to the front entrance of Wal-Mart and honked its horn. Upon contact by the investigators, it was determined that this was the vehicle sent by Taxi Specialties to provide the service. vehicle was not equipped with required placards, PSC plates, top light or identification numbers. It was subsequently discovered that the driver did not have a driver's license or identification on her person, that the vehicle was not registered to Taxi Specialties, there was no lease contract on file with the Commission, and there is no insurance held by Taxi Specialties that was applicable to this vehicle.

After due consideration of the circumstances, the Commission finds that applicant should be ordered to show cause on or before September 15, 2006, why its certificate should not be revoked or the authority holder fined for its failure to comply with the Motor Carrier Rules of the Commission.

## ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Rick Holloway dba Taxi Specialties of Lexington, Lexington, Nebraska, be, and it is hereby ordered to show cause why its Certificate of Public Convenience and Necessity should not be revoked or the authority holder fined for failure to comply with Commission rules on or before September 15, 2006, and a hearing was set for September 25, 2006, at 1:30 p.m. in the Commission Library, 300 The Atrium, 1200 N Street, Lincoln, Nebraska, and Educational Service Unit #16, 1221 W. 17th Street, Distance Learning Room, North Platte, Nebraska.
