## OPINION AND FINDINGS

On March 12, 2009, the Commission authorized Caring People Sudan, Omaha, to operate as a Contract Carrier. On October 27, 2009, Commission granted an extension of authority to Caring People Sudan.

On March 30, 2018, Caring People Sudan's insurance carrier submitted a Form K indicating their insurance would be cancelled as of May 6, 2018. Caring People Sudan was able to obtain insurance effective May 3, 2018, and a Form E was submitted. On July 3, 2018, the Commission received a second Form K indicating the insurance would be cancelled effective August 4, 2018. Department staff has attempted to work with Caring People Sudan, however, to date, no insurance is on file.

After due consideration of the circumstances, the Commission finds that Caring People Sudan, Omaha, should be ordered to show cause as to why its Permit of Authority should not be revoked for failure to maintain proper insurance. Therefore, hearing on this matter shall be held on **Tuesday**, **October 10**, **2018**, at **11:00 a.m**. in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
