BY THE COMMISSION:

On September 14, 2018, an application was filed by Leisure Limousine & Sedan, Inc. ("Applicant"), Lincoln, seeking to adopt a trade name, Van Go of Nebraska. Notice of the application was published in The Daily Record, Omaha, on November 7, 2018. No protests were filed; therefore, the application will be processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

Applicant operates as a Common Carrier with a Certificate of Public Convenience and Necessity under Certificate No. B-1718. In its application, Applicant seeks an order from the Commission approving adoption of the trade name Van Go of Nebraska for use in the van operations granted in Application No. B-1718.

Upon consideration of Applicant's filing and the files and records of the Commission relative to Applicant and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant has adopted a trade name, but no other aspect of the organization of Applicant has changed.
2. The authority held by Applicant should be carried in the files of the Commission in the new name of the Applicant to wit: Leisure Limousine & Sedan, Inc., d/b/a Van Go of Nebraska, Lincoln, Nebraska.
3. No further action or relief should be granted pursuant to Applicant's notification and request for official recognition of its new name.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the application of Leisure Limousine & Sedan, Inc. to adopt a trade name be, and is hereby, approved.
