OPINION AND FINDINGS

By application filed January 31, 2014, Papio Transport Service, Inc., Papillion, seeking to change the stock ownership as follows: Current Ownership: James Glover (100%); Proposed Ownership: John Miller (50%), Loren Stutheit (50%), through purchase of stock.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on February 5, 2014, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1733 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Papio Transport Service, Inc., is a corporation duly organized and existing under and by the virtue of the laws of the state of Nebraska with its principal place of business being in Papillion, Nebraska. The business headquarters of Papio Transport Service, Inc., will remain in its current location in Papillion, Nebraska, if the transfer of the stock of Papio is approved by the Commission. Applicant is in the business of providing transportation services. The Applicant currently provides service over irregular routes between points in Douglas and Sarpy counties. The Applicant will continue to provide the same service as that provided by Papio Transport Service, Inc.

The Applicants informed the Commission that they do not desire to have a new certificate issued but to allow the existing Certificate in B-1733 to remain in effect, with only the stock transferring to the Applicant. Consequently, Certificate No. B-1733 has not been cancelled and remains in effect. The Commission hereby finds that Certificate B-1733 should remain in effect and that a new certificate should not be issued.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicants are fit, willing, and able properly to perform the proposed service.
2. The proposed acquisition of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1733 is not dormant.
4. An order should be entered in Application B-1733 authorizing John Miller and Loren Stutheit to acquire control of Papio Transport Service, Inc., through the purchase of stock.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1733, be, and it is hereby, granted; and that Papio Transport Service, Inc., is hereby authorized to change its existing operation by the transfer of stock ownership as follows: Current Ownership: James Glover (100%); Approved Ownership: John Miller (50%), Loren Stutheit (50%).

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
