OPINION AND FINDINGS

By application filed December 29, 2014, Papio Transport Service, Inc., Papillion, seeks to change an existing operation by the transfer of stock ownership.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on December 31, 2014, pursuant to the rules of the Commission.

On January 27, 2015, a protest was filed by Camelot Transportation through its attorney, Tara Tesmer Paulson. On June 4, 2015, the protest was withdrawn. Application B-1733 was then processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Papio Transport Service, Inc., is a limited liability corporation duly organized and existing under and by the virtue of the laws of the state of Nebraska, with its principal place of business being in Papillion, Nebraska. The business headquarters of Papio Transport Service, Inc., Papillion, Nebraska, will remain in its current location in Papillion, Nebraska, if the transfer of the stock of Papio Transport Service, Inc., is approved by the Commission. Applicant is in the business of providing transportation services in Douglas and Sarpy counties by vans, SUVs, and sedans. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: Yes. The Applicant will continue to provide the same service.

As the protest was withdrawn, the matter proceeded on a modified basis.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed change of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1733 is not dormant.
4. An order should be entered in Application B-1733 authorizing Papio Transport Service, Inc., Papillion, Omaha, to change an existing operation by the transfer of stock ownership.

ORDER




IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1733, be, and it is hereby, granted; and that Papio Transport Service, Inc., is hereby authorized to change its existing operation by the transfer of stock ownership as follows: Current ownership: Loren F. Stutheit (50%) John Miller (50%); Proposed ownership: Papio Transport Holding Company (100%).

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and imitations which have been, or may hereafter be prescribed by the Commission.
