OPINION AND FINDINGS

By application filed September 26, 2011, Pristine Limousine, seeks to change the ownership of the certificate holders in Certificate B-1741 by the transfer of stock ownership.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on October 14, 2011, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1741 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Pristine Limousine applied to change the ownership of the certificate holders as follows: Current ownership: Jason Bryant, 100%; Proposed ownership, Dorothy M. Savory and Hubert W. Sorrells, 50% and 50%.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed acquisition of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1741 is not dormant.
4. An order should be entered in Application B-1741 authorizing Pristine Limousine, LLC, to change an existing operation by the transfer of stock ownership.
