OPINION AND FINDINGS

By application filed April 26, 2010, Grand Island, Nebraska, hereinafter referred to as applicant, seeks a Certificate of Public Convenience and Necessity to operate as a common carrier of passengers by motor vehicle as follows:

AUTHORITY SOUGHT

The transportation of passengers and their baggage by limousine service between points in Sherman, Buffalo, Custer, Garfield, Hall, Howard, Loup, Blaine, Valley, Greeley, Hamilton, Kearney, Phelps, Adams, Webster, Clay, Chase, Dundy, Hayes, Hitchcock, Frontier, Red Willow, Furnas, Gosper, Dawson, Harlan, Franklin, Nuckolls, Boone, Nance, and Merrick counties, and between points within said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. authority language for B-1758, including A, B, and C, to be repealed). Transportation in sedan, van and SUV style luxury limousine vehicles is authorized. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on April 30, 2010, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1758, Supplement 1, was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed service, and to conform to the provisions of Neb. Rev. Stat., sections 75-301 to 75-322.04, (Reissue 2003), and the requirements, rules and regulations of the Commission thereunder.
2. The proposed intrastate service is or will be required by the following extent:

SERVICE AND TERRITORY AUTHORIZED:

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1758, Supplement 1, be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Kravek, LLC, dba Aquila Limo Service, Grand Island, Nebraska, in Application B-1758, Supplement 1, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat. sections 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Reissue 1996), and with the rules and regulations of the Commission, and if upon expiration of such time applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.




IT IS FURTHER ORDERED that applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued to B-1758, Supplement 1.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
