BACKGROUND

On this 8th day of May, 2012, the Commission considered the Motion for Rehearing and/or Reconsideration filed in the matter of Limousine Services, LLC in Application B-1761.

The Commission entered an Order on April 17, 2012, granting the application of Limousine Services to add sedans to their authority. On April 20, 2012, the Protestants A-1 Transportation and Alford Oil Company filed a Motion for Rehearing and/or Reconsideration. An oral argument was scheduled for May 1, 2012, in the Commission Hearing Room.

At the oral argument, the Protestants stated that they did not believe there was sufficient testimony from public witnesses to support the granting of the application by the Commission. The Protestants argued that most of the witnesses were former employees of the Protestants, and that the lack of said witnesses should have been considered by the Commission in its determination of this matter. The Protestants further stated that they had provided sufficient evidence of the underutilization of its own services that no finding of public convenience and necessity should be found. The Applicant stated that there was sufficient evidence in the record to support the granting of the application.

OPINION AND FINDINGS

After being fully advised in the premises, the Commission is of the opinion and finds:

- 1. That the record before it does support the finding of the Commission that there should be a granting of the authority on the basis of public need and necessity.
- 2. The Motion for Rehearing and/or Reconsideration should be denied.
- 3. The Commission's order of April 17, 2012, in Application B-1634 should be affirmed.
