OPINION AND FINDINGS

By application filed August 5, 2014, Limousine Services, LLC, Omaha.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on August 27, 2014, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1761 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Limousine Services, LLC, Omaha, is a limited liability company duly organized and existing under and by the virtue of the laws of the state of Nebraska, with its principal place of business being in Omaha, Nebraska. The business headquarters of Limousine Services, LLC, will remain in its current location in Omaha, Nebraska, if the transfer of the stock of Limousine Services, LLC, of Omaha, is approved by the Commission. Applicant is in the business of providing transportation services by luxury limousine.

The Applicant currently provides services within a 250 mile radius of Dakota City over irregular routes. The transportation of railroad train crews is not authorized. HHS Designation: No. The Applicant was also approved to add sedans to vehicles used. The Applicant will continue to provide the same service.

As the matter was not protested, it proceeded on a modified basis.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed change of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1761 is not dormant.
4. An order should be entered in Application B-1761 authorizing Limousine Services, LLC, Omaha, to change operation by the transfer of stock ownership.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1761, be, and it is hereby, granted; and that Limousine Services, LLC, Omaha, is hereby authorized to change its existing operation by the transfer of stock ownership as follows: Jim Campin (100%).

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
