OPINION AND FINDINGS

By application filed July 27, 2011, Limousine Services, LLC, Lincoln, Nebraska, seeks to change the stock ownership as follows: Current Ownership: Mike Roth (100%); Proposed Ownership: James Campin (50%), Tom Schmidt (50%), in Certificate B-1761 through purchase of stock.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on September 7, 2011, pursuant to the rules of the Commission.

On September 7, 2011, a protest was filed by A-1 Limousine, VIP Limousine, and Alford Oil, by Bill Alford. Mr. Alford is now represented by Jack Shultz, Esq. On January 23, 2012, the protest was withdrawn. The application then proceeded on a modified basis. Application B-1761 was then processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed acquisition of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application B-1761 is not dormant.

4. An order should be entered in Application B-1761 authorizing James Campin and Tom Schmidt to acquire control of Limousine Services, LLC, through purchase of stock.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1761, be, and it is hereby, granted; and that James Campin and Tom Schmidt are hereby authorized to acquire control of Limousine Services, LLC, through purchase of stock as proposed by its application.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
