BY THE COMMISSION:

On September 13, 2010, an application was filed by MTBW, LLC, d/b/a TherAnBac ("Applicant"), North Platte, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers and their baggage in limousine service in open class service, and in charter bus service between points in Lincoln County, and between points in Lincoln County, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their luggage is not authorized, and the HHS Designation is no. The Application was granted on December 14, 2010; however, Applicant never finalized its approval by filing the required fees, insurance and rates with the Commission.

The Commission has attempted to contact Applicant by mail and telephone regarding the application. To date, Applicant has not contacted the Commission nor complied with the requirements to file its rates, fees and insurance.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **November 14**, 2016, the Commission will dismiss the application for failure to take timely action.
