BY THE COMMISSION:

On March 1, 2011, an application was filed by Royal Transportation Company, LLC (Applicant), Omaha, seeking authority as a contract carrier of passengers by van over irregular routes in Nebraska for the Nebraska Department of Health and Human Services. Notice of the application was published in The Daily Record, Omaha, on March 21, 2011.

Protests were timely filed by Transport Plus, Lincoln; Fairbury Taxi, LLC, Fairbury; Servant Cab, Lincoln; Panda Transportation, Valentine; Golden Plains Services, McCook; and Happy Cab, Yellow Cab, Checker Cab, DonMark, Inc., d/b/a Cornhusker Cab and Safeway Cab, all of Omaha (collectively, Omaha Cab Companies). All Protestants have withdrawn their protest except the Omaha Cab Companies.

Upon Applicant's request, a continuance of the hearing scheduled for January 25, 2012 was granted. On August 7, 2014, a letter was sent to Applicant to inquire on the status of the application. To date, Applicant has made no efforts to pursue the application.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **February 16, 2016**, the Commission will dismiss the application for failure to take timely action.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by Royal Transportation Company, LLC in Application No. B-1791 be, and is hereby, set for **February 16, 2016**.
