OPINION AND FINDINGS

By application filed March 28, 2013, Camelot Transportation dba Prince of the Road, Kearney, seeks to change an existing operation by the transfer of stock ownership.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on April 1, 2013, pursuant to the rules of the Commission.

Because no protests were filed, Application B-1802 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Camelot Transportation dba Prince of the Road, is a limited liability corporation duly organized and existing under and by the virtue of the laws of the state of Nebraska, with its principal place of business being in Kearney, Nebraska. The business headquarters of Camelot Transportation dba Prince of the Road, Kearney, Nebraska, will remain in its current location in Kearney, Nebraska, if the transfer of the stock of Camelot Transportation dba Prince of the Road is approved by the Commission. Applicant is in the business of providing transportation services statewide by passenger van, handicapped equipped passenger and cutaway vans. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. The transportation of passengers and their baggage point-to-point in Lancaster County is not authorized. The transportation services of passengers and their baggage originating within Lancaster County of groups of six (6) or less is not authorized. HHS Designation: Yes. The Applicant will continue to provide the same service.

As the matter was not protested, it proceeded on a modified basis.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

- 1. Applicant is fit, willing, and able properly to perform the proposed extended service.
- 2. The proposed change of control will be consistent with the public interest and will not unduly restrict competition.
- 3. The certificate issued in Application B-1802 is not dormant.
- 4. An order should be entered in Application B-1802 authorizing Camelot Transportation dba Prince of the Road, Kearney, to change an existing operation by the transfer of stock ownership.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1802, be, and it is hereby, granted; and that Camelot Transportation dba Prince of the Road, Kearney, is hereby authorized to change its existing operation by the transfer of stock ownership as follows: Sam Wisse (33-1/3%); Art Wisse (33-1/3%); and Kirk Nelson (33-1/3%).

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
