O P I N I O N A N D F I N D I N G S

On February 24, 2015, the Commission entered an order granting a suspension of authority for Black Out Express, LLC, d/b/a Black Out Express Party Bus ("Black Out"), Lincoln, for one year. The suspension ended February 23, 2016.

The Motor Transportation Department has communicated with Black Out about the necessary steps for compliance. On February 21, 2017, a Department Investigator spoke with a Black Out representative who indicated they would be in touch with the Department. The representative recently stated to Commission investigators that there was continued interest in coming into compliance; however, Black Out has failed to take the appropriate actions. As of the date of this Order, Black Out is not providing transportation services and does not have valid insurance in place.

After due consideration of the circumstances, the Commission finds that Black Out Express, LLC, d/b/a Black Out Express Party Bus, Lincoln, should be ordered to show cause as to why its Certificate should not be revoked for failure to maintain proper insurance and take action following suspension. Therefore, hearing on this matter shall be held on **Tuesday, October 10, 2018, at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.


